EXTENDED PRIVACY POLICY

Privacy regarding EU 679/2016

In accordance with Article 13 and 14 of EU Regulation 679/2016, ModenaFiere S.r.l. provides the following information:

1) Categories of data processed

ModenaFiere will process the following categorieS of data provided by you:

- Personal identification and contact data (such as name and email)
- Data related to profissional position
- IP address
- 2) The general purposes of data processing and the provision of personal data to ModenaFiere can be used for the following purposes:
- a) Compliance with contractual obligations related to participation in the selected event, including administrative and accounting purposes or pre-accreditation with the issuance of a specific entry pass to access the exhibition and/or the event mentioned in this form.

The purposes for which the personal data provided to ModenaFiere may be used include;

b) Fulfillment of legal obligations to which the company is subject.

In case of refusal, it will not be possible to establish any relationship with the data subject. However, for the purposes mentioned in points c) and d), providing consent is optional.

3) Data processing methods

The processing of data will be carried out using suitable methods and tools to ensure confidentiality. It may be performed through electronic or automated means (networked computers not accessible to the public) and non-automated means (paper archives), both provided with adequate security measures, such as personalized passwords with exclusive access, identification codes, and controls on archive access, in compliance with Article 32 of EU Regulation 679/2016.

4) Communication and disclosure of data:

Within the company, personal data may be accessed by partners, members of administrative bodies, company employees, the data protection officer, internal data processors, and individuals authorized to process personal data designated by the company in the course of their functions.

Personal data may be disclosed to qualified entities that provide the company with services instrumental to the purposes stated in the previous Article 2. These entities may include, but are not limited to, controlling, controlled, affiliated companies, the organizer of the event (if different from ModenaFiere), exhibitors, suppliers, contractors, subcontractors, banks and/or insurance companies, or other entities that provide services instrumental to the establishment and/or performance of any contractual relationship with the company (either on behalf of the company or independently). 5) Duration of processing

Your personal data will be processed only for the time necessary to achieve the same purposes for which they are processed and, in any case, for a period not exceeding 10 (ten) years.
